## **CHINAQFII.COM SPEAKS ON VENTURE FINANCING AT HARVARD UNIVERSITY AND MEETS WITH DFJ, VENTURE CAPITAL FUND IN SILICON VALLEY**

(Hong Kong, 26 February 2015) Mr. William KWOK, Chief Executive Officer of **ChinaQFII.com** (the “Company”), the first innovative platform which bridges China and global investors, was invited to deliver a speech on venture financing at The Harvard Project for Asian & International Relations (the “Conference”) held during 13-16 February 2015. Furthermore, ChinaQFII.com met with major venture capital including Draper Fisher Jurvetson (“DFJ”) in Silicon Valley after the Conference.

The four-day Conference, moderated by the World Economic Forum, ended successfully at Harvard University, MA, United States, covering topics such as venture capital, private equity in Asia, updates on Hong Kong startup companies and China deals of Qualified Foreign Institutional Investor (“QFII”), etc. The past Conferences invited various community leaders to deliver speeches, including Mr. Victor FUNG Kwok King, Honorary Chairman of Li & Fung Limited, Mr. Vincent LO Hong Shui, Chairman of Shui On Group, and Mr. Fred HU Ziliu, Founder of Primavera Capital Group and Former Chairman of The Goldman Sachs Group. ChinaQFII.com is the only Hong Kong startup company invited; its unique and innovative business model has been selected by the Conference for case study. Mr. Kwok’s speech was well received by the audience and stimulated enthusiastic discussion among participants. And “China QFII Guidebook – China Deals Review” written by Mr. Kwok was displayed in Baker Library of Harvard Business School and available for sale in the University bookstore.

ChinaQFII.com also met with renowned venture capital in Silicon Valley for the discussion of investment opportunities, including DFJ (seed investor of Facebook, Baidu, Tango, Skype, etc.) and Plug and Play Tech Center (seed investor of Google, PayPal, Dropbox, etc.). They expressed that the demand for investment and finance was huge among Chinese and US enterprises, and private equity enterprises in the US including venture capital and PIPE were enthusiastic to share the achievements in China’s growth; foreign institutions, however, often hesitated owing to their lack of familiarity with Chinese enterprises and the geographical barrier. As an effective platform connecting China and global investors, ChinaQFII.com is commissioned by the above mentioned fund to seek potential Chinese investors for projects across businesses including technology, media, telecom, education, environmental protection, etc.

Mr. KWOK stated, “This is our great honor to be the only Hong Kong startup company invited to speak at the Conference and to promote the development of venture capital with the exchange of ideas with global leaders. Looking forward, ChinaQFII.com will continue to give full play to its role as a bridge between China and global investors and open the investment gateway into China for the world. At the meantime, we hope to identify more strategic investment partners to co-develop Chinese and foreign markets, and aim to become a NASDAQ listed company.”


